

- d) To comply with the previsions indicated in article 6 of regulation 852/2004 from European Parliament and from Council dated April 29, 2004 related to the official controls, register and authorization and specifically oversee that this General Direction of regulation and inspection always and continuously get updated information about the branches, notifying any significant change in activities that are ongoing as well as from any company close outs.


